Rates and payment methods

New students: Entrance fee - Registration fees - Administrative follow-up:

- 1100 € payable at registration (non-refundable)
- **Students attending school in Eridan in N-1: Re-registration fees:**
 - 650 € payable on re-registration (non-refundable)
 - **All students: Schooling:**
- 20% of tuition payable at registration and cashed at that time (non-refundable)



PRIMARY

FULL-TIME :

- ❖ For kindergarten and elementary classes: **5300 € for the school year.**

HALF-TIME: only for the Nursery and Petite Section (reception only in the morning)

- ❖ **4000 € for the school year. No discount for siblings.**



MIDDLE SCHOOL

FULL-TIME :

- ❖ For the school year at the middle school: **5800 € for the school year.**



HIGH SCHOOL

FULL-TIME :

- ❖ For the school year at the college: **7050 € for the school year.**

Sibling reduction: - €500 for the second child of the same sibling
 - €1000 for the third child of the same siblings

For any annual cash payment (registration + tuition) before **15/07/2025**, you benefit from a discount of:

- €250 for 1 child, €300 for 2 children and €400 for 3 children

Any circumstances beyond our control leading to the partial or complete closure of the school for a period of more than one week will only result in a refund of the canteen, daycare, studies and recreational Wednesdays of the period concerned and upon written request from the families.

❖ Payment facilities

Parents have the option of paying the balance of the remaining 80% **of the school fees** in several instalments, according to the conditions defined below:

If you opt for the last of the instalments, regardless of the number of payments you choose to make, 50% of the tuition must be paid before 15/12/2025, and the balance before 15/03/2026.

In the event of non-compliance with these deadlines, the school management will be obliged to suspend the reception of your child(ren) until the schooling situation has been fully regulated.

Tuition fees:

The parent(s) declare that they are aware of the cost of their child's schooling at the school and undertake to jointly and severally cover the financial burden of the school.

Duration and termination of the contract:

This agreement is concluded for the duration of one school year and may be terminated by either party at the end of the school year.

However, it should be noted that the principle of "free choice" of parents in their registration process is a reciprocal principle of private law that can be denounced by either party (parents – school) subject to a clearly justified justification.

Termination during the school year:

➤ **At the initiative of the establishment:**

1/ In the event of a case of absolute necessity :

In the event of cessation of activity or imposed and definitive closure of the class, without reclassification of the pupils, the school will be liable to the parent(s) for the reimbursement of the sums corresponding to the services not provided.

2/ In the presence of a real and serious cause:

Unless there is a real and serious cause, this agreement cannot be terminated by the school during the school year.

The following are considered to be a real and serious cause for termination by the school during the school year:

- non-payment of the tuition fees due by the family to the school when due,
- inappropriate behaviour by the pupil which can lead to exclusion or by his or her family (or legal representatives).
- verbal and/or physical violence against another student, a teacher, a member of the teaching team

or the management.

- proven psychological harassment against another student, a teacher, a member of the teaching team or the management inside or outside the school or on social networks.
- repeated denigration of the school, its teachings or its representatives inside and outside the school or on social networks.
- deliberate damage to school property,
- or another cause recognized as such by the head of the school.

It is reminded that in the event of the student's exclusion or a real and serious cause for termination, the parent(s) remain liable to the establishment for the total cost of the annual tuition fees.

➤ **At the initiative of the parents or legal guardians:**

1/ Cancellation prior to the start of the school year:

In the event of cancellation of schooling before the start of the school year, parents are still required to pay the school 20% of the tuition fees as well as the registration or re-registration fees.

2/ Withdrawal during the school year:

In the event of abandonment of schooling by parents or legal guardians during the school year, they must notify the school's management by registered letter, signed by both legal guardians. The termination will take effect on the date of receipt of this letter by the establishment.

Financial Obligations:

If the abandonment occurs without a real and serious cause recognised by the head of the school, the parents remain responsible for the full payment of the annual school fees.

On the other hand, if a real and serious cause is recognized, the parents will be required to pay a termination indemnity. Real and serious causes may include:

- A move making it impossible to continue schooling in the school (at a distance of more than 40 km).
- A serious health problem requiring hospitalization for more than a month, without the possibility of following distance learning.
- Any other legitimate reason expressly accepted by the head of the school.

Termination at the end of the school year:

Parents or legal guardians are required to inform the school of their child's re-registration within one month of receiving the email issued by the school to this effect. In the absence of a response within this period, the school reserves the right to no longer guarantee the child's place for the following school year.

The school undertakes to notify the parents or legal representatives of the non-re-enrolment of their child for a real and serious cause (such as indiscipline, unpaid bills, or a disagreement on the educational project) at the end of the last class council.

Internal regulations:

By signing this school contract, families acknowledge that they have read the school's internal rules and that they adhere to them.

The internal rules do not need to be submitted at registration (only the internal regulations will be requested in September for secondary school students).

Appendix to the school contract

Swimming pool activity in primary school:

Swimming pool sessions are organised by the school for certain classes and their cost is included in the tuition fee. They are supervised by qualified lifeguards.

Language recreational Wednesdays for primary school:

From 1:30 p.m. to 4:30 p.m.: artistic or musical activities and English-speaking circus. Their cost is: €560 per year and €504 for the 2nd child. For a Wednesday occasionally: €40. **Childcare is possible until 6 p.m.**

Language recreational holidays up to 12 years old:

An English-speaking recreational holiday is organised over 5 weeks (one during the autumn holidays, one during the spring holidays and the first three weeks of July)

Optional activities are offered for primary and/or secondary school:

- **Extracurricular clubs:**

- Linguistics: Cambridge, Theatre, Choir...
- Artistic: Musical **awakening**, Guitar, Visual arts, Dance, Circus...
- Sports: Gym, Baby Gym, Football, Ball sport, Table tennis, Baby gym and gymnastics, Slackline...

The cost per club is €250 for a minimum of 25 sessions over the school year. The clubs are reserved for primary and/or secondary school students.

- **Cambridge examination:**

For the middle school students concerned. The cost of the examination is communicated to the parents. The preparation takes place in the school setting and is at no additional cost.

- **School trips:**

- Moyenne and Grande section: green class in line with the theme of the year.
- CP, CE1 and CE2: snow class.
- CM1 and CM2: exchange with a school in England and families.
- 6th: trip to Scotland.
- 5th, 4th and 2nd: defined at the beginning of the year
- For these school trips, families are asked for funding in instalments.

Internships in companies for middle and high school :

Internship sessions are offered, including for high school students, and we encourage internships abroad.

- **The PSC1 (Level 1 Civic Prevention and Rescue)** to raise awareness among our students about life-saving gestures.
